Regular City Council Meeting
April 9th , 2024

The regular City Council meeting was called to order at 6:37 PM by Mayor Kevin Bopp. Present were council members Luke Anderson, Neil Weaving, Al Colemer and John Stenvold . Also attending were Alicia Thompson, Sara Dux, Donovan Hajek, and Lyle Bopp.

All stood for the pledge of allegiance.

A motion was made by Al Colmer , seconded by John Stenvold to approve the agenda. Motion carried.

A motion was made by John Stenvold , seconded by Neil Weaving to approve minutes from the April 9th, 2024 regular city council meeting. Motion carried.

Sheriff Report: Not present

City Superintendent Donavon Hajek reported after going to the Mosquito control seminar we are going to try something new around town, controlling Larva and nesting sites for Mosquitos. Motion was made by Luke Anderson and John Stenvold for 2 boxes of Mosquito repellent pucks for Lake Lithia and other water spots around town.

There was a motion made for use of Prairie Dog Grant Funding for a purchase of a Generator for emergency transfer pump use and emergency lift station use and, the Reverse Osmosis Skid Membranes for the Water Plant. The motion was made by John Stenvold and seconded by Luke Anderson. Motion carried.

There was also a motion made to get quotes for Cement projects and sidewalk repairs around town, Al Colmer made a motion and John Stenvold seconded the motion. Motion carried.

Donavon also brought up the milling of Main Street- to smooth out last year's water main break. He then made mention of a request being made to plant 6 new trees at the Cemetery and is going to be contacting the Tree Committee about that, and removal of old ones that are falling down.

City Attorney Lyle Bopp has made two purchase agreements for the old Martinson building on Main Street and the FCDC house by Sanford Clinic , for the Slum and Blight grant to be de-constructed. A motion for approval to accept the two purchase agreements for the purchase of the FCDC house and Martinson Building was made by John Stenvold and seconded by Neil Weaving to be de-constructed upon approval of grant. Motion carried.

Spring pickup was discussed and Sara, Donavon and Alicia are going to be picking a date. Along with that we had scheduled Pet Day for April 24th 4:30-6 at the City Hall

In other business Brett Anderson contacted Alicia at the City Hall about a “ no thru traffic sign” due to living on a dead end street and having people turning around in his yard. Donovan has received the sign and going to be putting in place.

A motion was made by Luke Anderson and seconded by Neil Weaving to approve the City Auditor's report including the April financial statements, delinquency report, and payment of the bills.
