City of Forman, North Dakota Regular City Council Meeting July 17th, 2025

The regular City Council meeting was called to order at 6:00 PM by Mayor Kevin Bopp. Present: council members Mark Wyckoff, Kirk Fliehs and John Stenvold, City Superintendent Donavon Hajek, City Attorney Lyle Bopp and City Coordinator Sara Dux. Also present: Joel Quanbeck

All stood for the Pledge of Allegiance.

The meeting began with a presentation from Joel regarding Hazardous Mitigation Plans which are required by FEMA and detail the potential for 15 listed hazards and the objectives of mitigation. Gave examples of 4 kinds of mitigation and asked the council for specific concerns or projects that could reduce risks of hazards. Items that were brought up include the security of the water plant, possibilities of chemical spills for agricultural use, and upgrades for the siren at fairgrounds.

City Attorney Lyle Bopp mentioned meeting in Fargo on July 30; still working on updating city ordinances.
