Regular City Council Meeting
May 9th , 2024

The regular City Council meeting was called to order at 6:37 PM by Mayor Kevin Bopp. Present were council members Luke Anderson, Neil Weaving, Al Colemer . Also attending were Alicia Thompson, Sara Dux, Donovan Hajek, and Lyle Bopp.

Special guest Kallyn Stenvold won Mayor of the Day and was present- she led us with the Pledge of Allegiance
