The regular City Council meeting was called to order at 6:00 PM by Mayor Kevin Bopp. Present were council members, Luke Anderson, and Kirk Fliehs Also attending were Mayor Kevin Bopp, City Auditor Alicia Thompson, City Superintendent Donavon Hajek.

They had to replace a motor at the lift station over by kwik stop that had gone out. Garbage truck has been having some issues; they had put a new Alternator in it. They are working on getting equipment ready for the first snowfall.

City Coordinators Report- working on getting some new grants.
